#### **Purpose of Report**

#### Background

The Department of Infrastructure Planning and Logistics has committed to funding of \$227,272.73 (excluding GST) for extension works to the Don Dale Pavilion on the Project Site, being Lot 3217, Town of Katherine, for its use as an all-purpose community centre. #### Purpose of Report
